1. Owner agrees to pay all costs and charges for boarding, grooming, daycare, special services, veterinary costs, etc. for pet during the time of care in the Kennel. Owner further agrees that the pet shall not leave the Kennel until all charges are paid to Amherst Boarding Kennel, LLC (Kennel).
2. All pets are boarded, trained, or otherwise handled or cared for by Kennel without liability on Kennel's or either staffs part for loss of damage from disease, death, running away, theft, fire, injury to persons, other pets, or property by said pet, or other unavoidable causes, due diligence and care having been exercised. Owner expressly agrees that Kennel's liability shall in no event exceed the lesser or current chattel value of a pet of the same species or the sum of \$300 per animal boarded.
3. If a pet becomes ill, owner agrees that Kennel has the right to contact owner's veterinarian for services. If no veterinarian is designated, or owner's veterinarian is unavailable, Kennel has the right to contact a veterinarian of their choice: the owner of the pet shall pay such expenses. The owner agrees to be responsible for all charges related to veterinary care.
4. Kennel will not be responsible for any personal items left with pets while staying at the Kennel.
5. If the owner neglects to pick up the pet(s) within five (5) days after receiving written notice that it is ready for release, sent via registered mail to the above address, Kennel may assume that the pet(s) are abandoned. Under such circumstances, Kennel is then authorized to dispose of the pet(s) as they see fit. The owner further realizes that abandonment does not release them from their obligation to pay the entire bill in full.
6. Kennel agrees to exercise due and reasonable care and to keep the Kennel premises sanitary and properly enclosed. The pets are to be fed properly and regularly, and to be housed in clean, safe quarters.
7. Kennel reserves the right to contact the owner and terminate the stay of the animal on the premises. The owner will be required to remove the animal from the premises within 24 hours. Failure to remove said animal within this period permits Kennel to place the animal in veterinary care where measures can be taken to tranquilize or dispose of said animal. All costs shall be borne by the owner of the animal, as well as the costs for the actual stay at the Kennel as per rates on contract.
8. The pet(s) will be released only to the owner or to an individual(s) designated by the owner in writing at drop off.
9. There will be a \$30 fee assessed to the owner for any returned checks.
10. If it shall be necessary for Kennel to commence any collection or legal proceedings to collect any sums due from owner under this contract, owner shall be responsible for Kennel's reasonable collection or attorney's fees incurred in any such proceedings.
11. This agreement shall be valid for dog daycare dates in the year \_\_\_\_\_.
12. Owner of pet(s) listed herein agrees/understands that Dog Daycare involves socialization and playtime exercise with other pets that could result in pet(s) sustaining minor injury and Owner agrees to hold Kennel harmless for any and all veterinary costs.
